

Planning for the Future – Digitizing Our History

In October of 2022, our OFPA Governor General Ed Horton established the Archives and Records Committee with the specific mission of getting all of our 127 years of Approved Applications scanned and digitized.

Currently all applications, starting at the Order's inception in 1896, are housed at the University of Baltimore Library.

While some applications and supporting documentation in those archives have been digitized over the last few years, none have been indexed by a man's name in order to be a part of a searchable database.

To date, the only access to any archived information is through a known national number, which the archivist can use to scan what is available on paper under that national number. This makes the use of our archives of limited use in researching ancestral information for new applications. In other words, you have to know a man's OFPA national number in order to find out what was on his application and what sources he used for his documentation.

The Committee's search led us to the New England Historic Genealogical Society (NEHGS) in Boston. We have negotiated a License Agreement with NEHGS that will result in the digitization and indexing of over 6400 archived applications.

There is no cost to OFPA for the digitization and indexing service because the licensing agreement is for the benefit of both OFPA and NEHGS. We get our applications digitized and indexed for the benefit of our Order, and NEHGS gets a license to sell digital copies of the scanned documents to their subscribers. There is no transfer of ownership to NEHGS. We retain ownership of the data, but we are giving the NEHGS a non-exclusive license to use the scanned documents for their profit.

NEHGS will create an index from the Membership Applications and publish the images and index as a searchable database on the NEHGS. NEHGS will also provide copies of all images to OFPA in both archival format (TIFF), and web format (JPEG), when the digitization process is complete.

NEHGS will index every record having either an associated name or date. This includes birth, marriage, military, probate, death, divorce, etc., for every name listed on an application. Lineage society application databases are most useful for NEHGS when all names and records listed on them are searchable.

The 127 years of archived applications and supporting documentation are being prepped for transfer to NEHGS, and should be ready for transport to NEHGS in early July. We expect the digitization and indexing project to be complete in 2024. We will keep you advised as this project progresses toward a useful, genealogical search tool for our membership.

Supplemental Applications

Periodically, an associate discovers that he can trace a second (or third) lineage back to a Patriot/Founder, in addition to the one that is cited in his approved application. And the associate would like to have the OFPA recognize that second lineage.

This potential for identifying a second qualifying lineage has expanded since 2020 with the change of membership requirements allowing a potential associate to use his immediate male or female parentage (mother/father, grandfather/grandmother, great grandfather/great grandmother) to trace his lineage from a direct male ancestor who was alive when the OFPA was founded on 16 March 1897.

The following is the process for submitting a Supplemental Application:

- Complete a long application form (https://ofpa.org/webServices/files/forms/ OFPA_Long_Form_Fillable_11_Jun_2023.pdf). On the long form, the approved national order number should be filled in on the upper right of Page 1, as well as the Society number on the upper left.
- 2. Also, on the first page of the application, third line, there are two boxes for "Initial" and "Supplemental". Check the "Supplemental" box.
- 3. Within the lineage lines, pages 2-4, any line that is a duplicate from the initial approved application may reference the approved application as the source document. If the lineage follows any of the generations of the original application, the applicant may refer to them by the generation and member number. Example: Gen 1 John Hancock

 Reference: Nat # xxxx
- 4. Be sure to include a copy of the initial approved application complete with the cover letter from the Registrar General as the source document for that line. If the initial approved application covers the first 2-4 lines of the supplemental lineage, that source document only needs to be provided once.
- 5. Of course, each new line of the supplemental lineage needs to be fully documented to OFPA documentation standards. From that male ancestor who was alive on or after 16 March 1897, there must be a direct male lineage back to the Patriot and Founder.

The national fee for submitting a Supplemental Application is \$150, while an initial application fee is now \$200. We are still deliberating the Society fee for a Supplemental Application and will let all know once the Executive Council has discussed it, proposed it, and voted on it (probably mid to late summer 2023). Once approved, the Registrar General will include an "S1" (and/or "S2" if additional Founders are submitted) after the National Order No, designating the lineage as supplemental. And an additional membership certificate will be issued in due course.

Carroll 'Parish' Award* which recognizes annually the Society demonstrating the highest overall performance in accomplishing the objectives of the Order. The award is made only by the National Order. The selection of the Society to be the recipient of this award is made by the General Court based upon evaluation of Society activities for the previous year--in this case for calendar year 2022. To be eligible for consideration and to compete for this award, a record copy of the Society Governor's Report must be submitted to the Governor General and the Secretary General which is based upon those activities participated in by the Society Associates throughout the year.

The major highlight of the 2023 General Court was the award ceremony where the Virginia Society was

presented, the highly prestigious *H. Carroll 'Parish' Award*. This presentation marks your Virginia Society having earned this award for 15 years in a row!

The various activities your Virginia Society participated in include, but are not limited to, attendance at meetings whereby an Associate provides OFPA greetings. Attendance additionally includes those numerous lineage society events, presentations of ROTC and JROTC Awards at numerous Colleges and Universities and JROTC High Schools. It additionally includes awards presented to National Guard Units as well and presentation of the prestigious Lt General Herman Nickerson Award at the United States Naval Academy. Other events include special projects completed throughout the year by your Society such as the recently conducted grave marking of the Founder Theodorick Bland. These numerous events that your Virginia Society participates in are intended to extend public awareness of the OFPA through our newsletters and coverage of our activities in the news media. Congratulations to all of you that contributed countless hours, as Associates of the most prestigious Society of the OFPA.

Afterwards, the group was invited to tour the mansion and grounds.






Westmoreland County. Associate Peter Broadbent was present to deliver remarks to assembled audience.

David Lawrence Grinnell



Our esteemed colleague and Associate, Registrar General David Lawrence Grinnell passed quietly last Tuesday, the 18th of April.

He was a kind, gentle soul who did yeoman service on behalf of our Order nearly to the end. His tenacity and dedication were responsible for the marked increase in efficiency in the processing of membership applications in recent years. He will be missed by all.

He was born on September 17, 1943, to Clairmont and Mildred Grinnell of Newport, Rhode Island. He spent most of his life on Aquidneck Island with his family and friends.

He graduated from Newport HS in 1962 and in 1966 he received his BS in Business Finance at Bryant College. David was the VP of Finance at Edgehill Newport from 1979 until they closed. He then became the CFO at Codac for many years. He moved to Cranston RI in 2003 and in 2009, when he retired, moved to Palm Springs CA with his husband, Victor M Ranieri.

He is survived by two children, his son, Nathan Grinnell and wife Jaclyn of Georgia, two grand-children, Ryder and Lila Grinnell also of Georgia, his daughter, Jodi Grinnell Brierley of Missouri, and his husband. He is also survived by a brother in Newport RI, Ronald Grinnell, 3 sisters in law, and many nieces and nephews. Two other brothers, Alfred and Roger Grinnell, predeceased him.

Besides the OFPA, David was a member of the SAR, the Mayflower Society, and many other genealogical groups. He often held an office in several of these groups, either as treasurer or registrar.

David's final arrangements were made by All California Cremation and his ashes were scattered in the Pacific Ocean. He will be missed by many family members, friends and professional organizations.
