The Virginia Society can be very proud of its Reserve Officer Training Corps (ROTC) Recognition Program. For a Society of our size it's probably one of the finest in the Order. The program truly got jump started in 2002 when Associate Thatcher Wood organized presentations to three Colleges and Universities in the Hampton-Williamsburg-Richmond area. Under his guidance and with his persistence it has now grown to 15 awards at eight different institutions. The Outstanding State ROTC Cadet or Midshipman Award is presented to a Cadet or Midshipman who has demonstrated superior "qualities of dependability, character, military discipline, leadership, patriotism, and an understanding of the importance of the American Heritage." This program is the hallmark of our Society

The spring 2008 meeting is being planned for Saturday April 5th, 2008 at the Best Western in Culpeper, VA. The speaker will be Charles Phebus, VA OFPA Historian. He will speak on his 4th great grandfather, John Shepherd. Patriot Shepherd was the longest living survivor of Braddock's Defeat in 1755, and a Revolutionary War veteran who passed away at 117 years and 9 months of age.

For anyone who cares to do wine tasting tours, on Friday April 4th, Jerry will be organizing a wine tasting tour to one of Culpeper's vineyards and will be offering a wine tasting tour on Saturday after the meeting. There is an additional cost for the wine tasting tour about \$5.00 each (unless prices go up). Unfortunately The Times Have Caught Up With Us!

Back in 1992 an august group of fiscally responsible gentlemen agreed that the Virginia Society of the OFPA could operate quite nicely with Society membership dues set at the reasonable sum of 15 dollars per year. After all, milk only cost 99 cents a gallon, a whole loaf of bread was on the shelf at the corner grocery store for 70 cents a loaf, and the dues notice was mailed out with only a 29 cent stamp on the envelope.

And so it went, time passed, the years rolled by, until we came to 2007. And another august group of gentlemen gathered around a table to discuss the health of the Society. One member remarked that he could not even buy a glass of milk at McDonalds for 99 cents let alone a gallon, another said at the chain store that replaced his corner grocery story a loaf of bread cost \$2.49. The Secretary commented that with this year's stamp hike each envelope would now need a 41-cent stamp.

But our Treasurer calmly noted and said, "Ah, yes,

prices and costs have gone up since 1992 but our Society dues have NOT." That's 15 years without a dues increase

Then came the realities that our income from dues was no longer covering our simple expenses. In fact during the past two years we have had to withdraw funds from our 'savings' to make ends meet.

Our expenses are primarily the cost of supporting our aggressive and excellent ROTC award program, publishing several 'top notch' bulletins a year, and ensuring that we can continue to honor the increasing cost of life memberships. Last year two of our Associates who had been making substantial 'extra' donations in support of the ROTC program passed away. All who knew them will miss these gentlemen and the ROTC program will miss their contributions.

After a great deal of honest, frank discussion at the March 2007 VA Society meeting a vote was taken to increase the dues for the first time in 15 years from\$15.00 to \$21.00 for the year 2008. The Associates also agreed to review the financial situation of the Society next year and if, but only if, need be, seek another \$6,00 increase in 2009 to \$27.00 per year.

These decisions were not made lightly, there was much talk about the impact a dues increase might have on membership retention and new applications, but the Society simply can not keep 'dipping' into its meager reserves routinely to cover 'normal expenses.'

The Virginia Society Council sincerely hopes every Associate can understand why, that after 15 years, our dues do have to be raised.


